The Proof level membership in KDA is for licensed distillers in Kentucky that maintain an inventory between 10,000 barrels (or barrel equivalent) and 24,999 barrels of distilled beverage spirits each year. KDA Heritage members, or their individual distilleries, are not eligible.

Prospective Proof members are encouraged to seek sponsorship by at least one member in good standing of the Kentucky Distillers' Association Board of Directors. All applicants provide a signed agreement of the DISCUS Code of Responsible Practices for Beverage Alcohol Advertising and Marketing that is included in this application.

Annual dues are based on barrel inventory as of Dec. 31 the preceding year, and are calculated at a rate prescribed each year by the KDA Board of Directors. Proof Distillery dues for FY 2015 are \$1 per barrel.

There is a one-time initiation fee calculated at the rate of \$1 multiplied by two times the applicant's barrel inventory. This fee shall be credited towards the initiation fee required for a Heritage Member if and when the applicant reaches the minimum standards for that level.

In the event an application for Proof membership is denied by the KDA Board of Directors, the Association will refund the applicant's initiation fee.
